Booth Registration Information & Conditions

Payment Terms: Completed application and payment MUST be received by June 1st, 2019 to confirm space. Cheques should be made payable to **OFMF 2019**.

Completion of this application implies that you have read and agree to comply with the conditions of contract, and understand that any rules and regulations that are not adhered to will result in the termination of your right to exhibit at the OFMF 2019 Rendezvous.

Conditions of Contract: (HPTA)

The Exhibitor agrees to abide by all regulations and rules adopted by Ontario Fur Managers Federation (OFMF) in the best interest of the Rendezvous, and agrees that the OFMF shall have the final decision in adopting any rule or regulation deemed necessary prior to, during and following the Rendezvous.

The Exhibitor will be liable for and will indemnify and hold harmless OFMF and the Huron-Perth Trappers Association (HPTA) from any loss or damages whatsoever as a result of any person or company, including, without limiting the generality of foregoing, Exhibitor, other Exhibitors, OFMF, HPTA, the owner of the property and their respective agents, servants and employees and members of the public attending the Rendezvous, either on the said space or elsewhere if said loss or damages arose or were in any way connected with the Exhibitor's occupancy of said space.

The contract may be broken by either party, provided written notice is received by the other at least 90 days prior to the first day of the event, in which case all monies paid by the Exhibitor will be refunded. If the Exhibitor cancels within 60 days prior to the event, he/she will be liable for 50% of the total cost of the contracted space fees. If the Exhibitor cancels within 30 days prior to the event, he/she will be liable for 100% of the total contracted space fees. In the event that the OFMF event is cancelled for any reason, the Exhibitor waives any and all damages and claims for damages, and agrees that the sole liability of the OFMF shall be to return any payment made by the Exhibitor of the space fees.

By cancelling this contract the Exhibitor forfeits all rights or claims to the allocated space and OFMF is free to rent it to others, and collect the cancellation charges as liquidation damages. Space contracted by the Exhibitor may not be sublet without the prior written permission of the OFMF. The OFMF reserved the right to alter or change the space assigned to the Exhibitor.

The OFMF reserves the right at any time to alter or remove exhibits or any part thereof, including printed material, products, signs, light or sound, and to expel exhibitors or their personnel if, in OFMF's opinion, their conduct or presentation is objectionable to other Rendezvous participants.

The Exhibitor agrees to confine their presentation within the contracted space only and within the Rendezvous rules and regulations, and to maintain a staff member in the Exhibitor's booth space at all times. The Exhibitor further agrees to place their display in a manner in which line of sight is maintained for the neighboring exhibit.

The Exhibitor assumes the risk of exhibiting and should any exhibit or part thereof, or any property in connection therewith be injured, lost, stolen, damaged, from any cause whatsoever before, during the Rendezvous or after the Rendezvous closing. OFMF is not liable therefore in any many whatsoever.

The exhibitor agrees that no display may be dismantled or good removed during the entire run of the Rendezvous, but must remain intact until the closing hour of the last day of the Rendezvous, except those items purchased by an attendee of the Rendezvous. The Exhibitor also agrees to remove the exhibit, equipment and appurtenance from the Rendezvous site by final move-out time limit, or in event of failure to do so, the Exhibitor agrees to pay for such additional costs as may be incurred.

The OFMF reserves the right to cancel this contract and withhold possession of exhibit space if the Exhibitor fails to perform any material condition of this contract or refused to abide by the Rendezvous rules and regulations, in which case the Exhibitor shall forfeit as liquidation damages and space rental payments made by the Exhibitor and any further occupancy of such space.

The Exhibitor agrees to observe agreements between OFMF and any official contractors serving companies on the Rendezvous site, according to the labour of the jurisdiction in which the OFMF Rendezvous site is located.

Smoking is NOT permitted in any of the buildings.

Rendezvous set up can begin on the afternoon of Thursday, August 22, 2019. There will be NO VEHICLES permitted into the tent, unless they are display vehicles.

Rendezvous move out will take place immediately following the Rendezvous and must be cleared out by 5pm on the night of closing. All equipment and related exhibit items are to be removed from the Rendezvous Arena. A daily fee will be charged for any exhibit items remaining after that date, unless agreed upon with the OFMF Rendezvous staff.

By signing this I confirm that I have completed the registration form, and that I have read and agree to the above stated rules. I agree to abide by the above rules for the duration of the OFMF 2019 Rendezvous.
